4. FIRST AID MEASURES

5. FIRE FIGHTING MEASURES

Suitable Extinguishing Media: Keep fire exposed containers cool by spraying

with water. Appropriate fire extinguishers are CO2, Powder or Alcohol resistant foam. Use extinguishing media appropriate to the

surrounding conditions.
